**PROCUREMENT OF SEASONAL INFLUENZA VACCINES FOR INOCULATION OF
HUJJAJ DURING HAJJ 2014**

INVITATION FOR BIDS

Ministry of Religious Affairs & Interfaith Harmony, Government of Pakistan, Islamabad invites sealed bids from the original manufacturers/ authorized sole agents of vaccines, **duly approved by WHO and registered with Drug Regulatory Authority Pakistan (DRAP), Ministry of National Health Services, Regulations & Coordination , Government of Pakistan, Islamabad** for provision of vaccine as detailed below for inoculation to the pilgrims for **Hajj-2014** in separate sealed covers on delivered duty paid (DDP) basis at NIH (EPI's warehouse), Chak Shahzad, Islamabad:

Specification	Quantity
Seasonal Influenza, single dose, preferably in pre-filled syringes and additionally 150,000 syringes (1-CC) for inoculation of meningitis vaccine	145,000

2. The terms and conditions are as under:-

- Single stage-two envelopes bidding procedure as specified in the Public Procurement Rules Authority (PPRA) 2004 shall be applied. The amount of bid Security/ earnest money in the shape of pay order/bank draft is required to be enclosed with technical bid.
- Vaccine should be registered with Drug Regulatory Authority Pakistan (DRAP), Ministry of National Health Services, Regulations & Coordination , Government of Pakistan, Islamabad
- The Vaccine meets the WHO requirements for biological substance.
- The vaccine should have minimum 50% shelf life at the time of delivery at Pakistan.
- Rates offered will remain unchanged in any case.
- The validity of rates quoted shall not be varied in any circumstances.
- Vaccine should be supplied at destination, under strict cold chain maintenance, preferably within Four weeks after issuance of supply order.
- Financial bids of only technically qualified bidders will be opened.
- The bidder shall be bound to take back the unutilized doses on its own cost and payment will be made against actual utilization.
- Repacking of vaccines is not allowed in Pakistan.
- Part supply Bid can be considered, subject to rate offered by lowest bidder.

3. The documents to be attached with the bid are as follows:-

- Manufacturer's Authorization Form (as per attached specimen).
- Copy of GST certificate and NTN No. should be written in tender letter in case of the supply through authorized sole agent.
- Certificate of Registration with WHO and Drug Regulatory Authority Pakistan (DRAP), Ministry of National Health Services, Regulations & Coordination , Government of Pakistan, Islamabad
- Bid security equivalent to **10%** (refundable) of the total tender amount, in the shape of bank draft/Pay order from any scheduled bank in favor of the "Ministry

of Religious Affairs, Government of Pakistan. Islamabad is to be attached (Bank guarantee is not acceptable).

- A certificate mentioning the name of countries where vaccine is supplied by the manufacturers.

4. Interested bidders are required to submit sealed bids on or before 13.05.2014 at 1100hrs positively in the office of the Section Officer (HP), Ministry of Religious Affairs & Interfaith Harmony, Government of Pakistan, Civic Center, and Islamabad. The bids received till the stipulated date/ time will be opened on the same day at 1230hrs in the presence of Bidders/ their authorized representatives.

5. The Competent Authority reserves the right to accept or reject any or all bids for which reasons on request shall be communicated to the concerned bidder.

6. The tender documents may be obtained from the office of the undersigned on submission of written application along with payment of a non-refundable fee of Rs.1000/- in the form of DD/Pay Order in favour of M/o Religious Affairs & Interfaith Harmony.
