

Subject: **PERFORMANCE GUARANTEE @ 5% FROM HGOs – HAJJ 2015.**

According to Clause 21(II) of Hajj Policy 2016 read with Clause F-VII of Service Provider Agreement, 2016, each HGO is required to submit performance guarantee @ 5% of packages (package x quota) in the form of Bank/Cash Guarantee, valid for one year.

2. All HGOs are therefore required to submit bank guarantee valid for one year (from the date of issue) on the attached format, at the time of submission of hajj application forms and other documents to concerned Directorate of Hajj.
