Whereas the Pakistan Hajj Mission desires to outsource the total management (including recruitment, training and deployment) of approximately 700 Local Khuddam ul Hujjaj (Arabic-speaking Pakistani individuals residing in KSA) as well as develop an automated complaint registration and grievance redress management system to improve the welfare services of Pakistani Hujjaj during Hajj, 2011.

- (iv) Should be a registered Company under relevant authorities in KSA.

- (vi) Has not been convicted / involved in any criminal/ civil/ administrative offence, particularly an offence relating to dishonesty, fraud / forgery, financial /investment/ / business crime/ misconduct or other criminal acts or been involved in any acts of misfeasance or serious misconduct.
